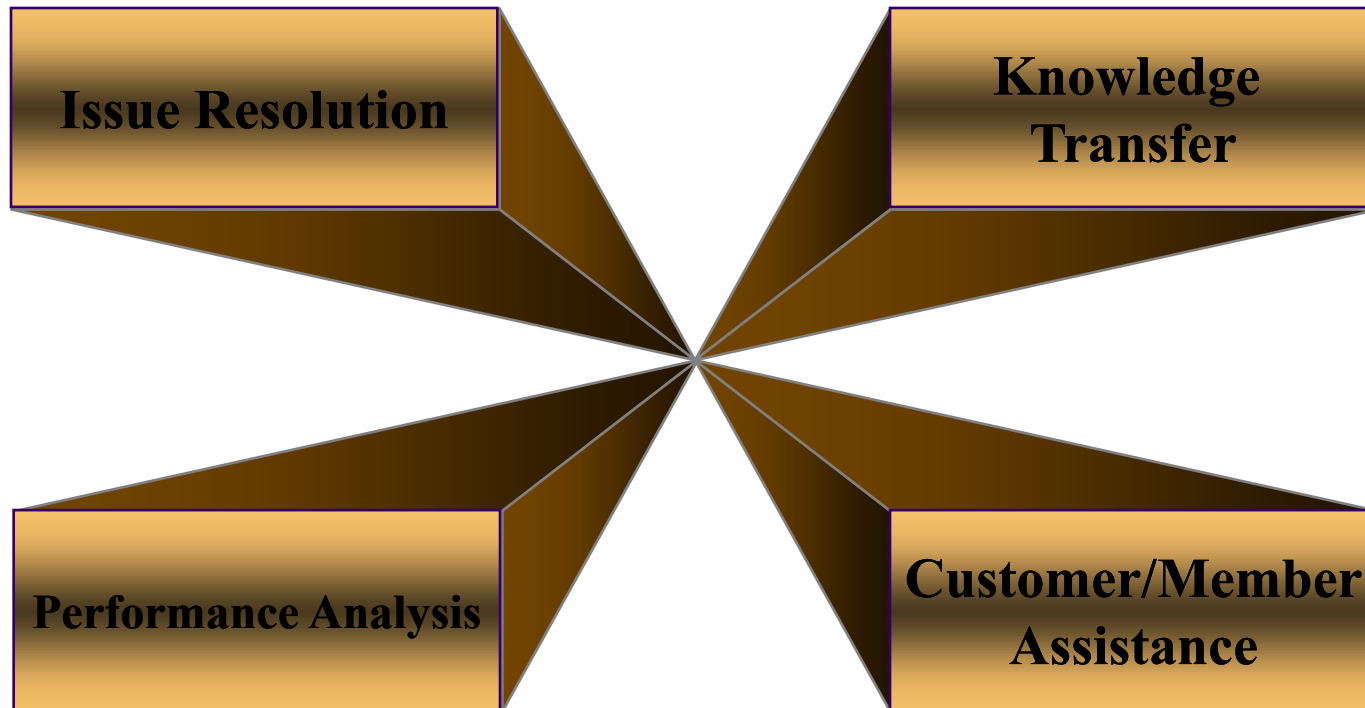


EFCOG Overview

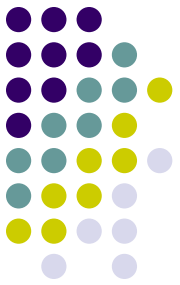


- Founded in 1990 by defense program contractors.
